**WHEREAS**, the Township of Long Beach wishes to award a contract without competitive bidding for professional services pursuant to NJSA 40A:11-5(a)(a)(i). Such contract and resolution are available for pubic inspection at the office of the Township Clerk; and

**WHEREAS**, the statute defines professional services as services rendered by a person authorized by law to practice a recognized profession, which practice is regulated by law; and

WHEREAS, upon the advice of counsel the Township of Long Beach has determined that it would be prudent to have the hearing conducted by a responsible independent Hearing Officer regarding a personnel matter; and

WHEREAS, retired Superior Court Judge Douglas T. Hague was recommended as a Hearing Officer and awarded a professional service contract with the Township of Long Beach pursuant to Resolution 08-0104.05; and

**WHEREAS**, objections have been raised that the Honorable Douglas T. Hague would not be a fair and impartial Hearing Officer; and

**WHEREAS**, the Honorable George L. Seltzer has been recommended as an impartial replacement as Hearing Officer in the above-mentioned personnel matter; and

**WHEREAS**, neither side has raised an objection nor rejected the professional services of the Honorable George L. Seltzer.

**NOW, THEREFORE, BE IT RESOLVED** by the Board of Commissioners of the Township of Long Beach at a regular meeting held Friday, March 7, 2008 that the Honorable George L. Seltzer be and is hereby appointed as Hearing Officer to conduct the Hearing concerning a personnel matter at a rate of Five Hundred Dollars (\$500.00) per hour.

WHEREAS, in accordance with N.J.S.A. 40:A11-6.1, the Long Beach Township Beach Patrol Department solicited quotations for the repair safety equipment, including seven (7) beach patrol boats; and

WHEREAS, in response to the invitation for solicitation two (2) quotations were received; and

**WHEREAS**, the quotations were reviewed by the Board of Commissioners of the Township of Long Beach and it was determined that Wood's Boat Service provided the lowest qualified quotations in accordance with the specifications, said quotations in the total amount of Three Thousand Eight Hundred Sixteen Dollars and Ninety One Cents (\$3,816.91); and

WHEREAS, it is in the public interest of the Township of Long Beach to award a contract to Wood's Boat Service for repair/refurbishment of various Beach Patrol safety equipment; and

WHEREAS, the Chief Financial Officer has certified that sufficient funds are available in the appropriation created by Lifeguards: Other Expenses.

**NOW, THEREFORE, BE IT RESOLVED** by the Board of Commissioners of the Township of Long, County of Ocean, State of New Jersey, at a regular meeting held this 7<sup>th</sup> day of March 2008 that the Mayor and the Municipal Clerk are hereby authorized to execute a contract with Wood's Boat Service, 10 West 17<sup>th</sup> St., P.O. Box 173, Barnegat Light, NJ 08006 in an amount not to exceed Three Thousand Eight Hundred Sixteen Dollars and Ninety One Cents (\$3,816.91).

RESOLUTION AUTHORIZING EXECUTION OF INTER-LOCAL MUNICIPAL AGREEMENT BY AND BETWEEN THE TOWNSHIP OF LONG BEACH, A MUNICIPAL CORPORATION OF THE STATE OF NEW JERSEY, AND THE BOROUGH OF BARNEGAT LIGHT, A MUNICIPAL CORPORATION OF THE

STATE OF NEW JERSEY, AUTHORIZING THE TOWNSHIP OF LONG BEACH TO PROVIDE BUILDING INSPECTION SERVICES FOR BUILDERS IN THE SAID BOROUGH WHICH BUILDER HAS A CONFLICT OF INTEREST WHICH DISQUALIFIES THE BARNEGAT LIGHT BUILDING DEPARTMENT FROM ISSUING BUILDING PERMITS AND INSPECTING OTHER CONSTRUCTION IN THE BOROUGH PURSUANT TO N.J.A.C. 5:23-4.5 (I) 2 (j) 1

WHEREAS, the Township of Long Beach and the Borough of Barnegat Light have contiguous borders; and

**WHEREAS**, the Department of Community Affairs adopted a regulation codified in N.J.A.C. 5:23-4.5 (I) 2 (j) 1 providing that "No person employed by an enforcing agency as a construction or sub-code official or as an inspector shall carry out any inspection or enforcement procedure with respect to any property or business in which ... any other public official or employee having any direct or indirect control over the funding or operations of the enforcing agency or any close relative or household member of any such public official or employee, has an economic interest ... "; and

**WHEREAS**, N.J.A.C. 5:23-4.5 (I) 2 (j) 1 provides, "Where an inspection or enforcement procedure is necessary or required in any such property or business and there is no other person employed by the enforcing agency who is qualified, pursuant to this chapter, to perform the inspection or enforcement procedure and who is not a subordinate of the person with the direct or indirect economic interest in such property or business, the official or inspector shall arrange for the inspection or enforcement to be carried out either by another local enforcing agency or by the department."; and

**WHEREAS**, the Borough of Barnegat Light has requested that members of The Long Beach Township Building Department issue permits and provide inspection services as Building Inspector for buildings being constructed, or to be constructed in the Borough of Barnegat Light in cases where conflict as described above exist; and

WHEREAS, the Board of Commissioners of the Township of Long Beach has determined that if an appropriate agreement can be worked out in the form of an Inter-local Agreement by and between the Township of Long Beach, a Municipal Corporation of the State of New Jersey, and the Borough of Barnegat Light, a Municipal Corporation of the State of New Jersey, that in a spirit of cooperation Long Beach Township would be willing to enter into such an Inter-local Agreement provided the Township Attorney of The Township of Long Beach approves the form and substance thereof; and

WHEREAS, Long Beach Township is always cognizant of being a good neighbor to other Municipalities located on Long Beach Island; and

**WHEREAS**, the local Building Departments of all Island Municipalities rely on the County of Ocean Building Inspection Department to perform electrical inspection, plumbing inspection and fire inspection services and compensate the County of Ocean for such services, being compensated themselves by receiving 10% of the fees charged to compensate said municipalities for time and effort and issuing such permits and in being involved in scheduling certain inspections.

**NOW THEREFORE, BE IT RESOLVED**, by the Board of Commissioners of the Township of Long Beach at a regular meeting held Friday, March 7, 2008, that the Mayor of Long Beach Township is hereby authorized and directed to enter into an Inter-local Agreement with the Borough of Barnegat Light for Building Inspection Services; and

**BE IT FURTHER RESOLVED**, that the actual issuance of permits after having been approved by the Director of the Construction / Zoning Department of the Township of Long Beach, shall be issued individually by the Borough of Barnegat Light, and for such clerical work the Borough shall receive compensation in the same percentage as all Long Beach Island municipalities receive from the County of Ocean for inspections of electrical, plumbing and fire on construction in Long Beach Island municipalities, with the balance of required fees paid to Long Beach Township.

### **COMMISSIONERS' REPORTS**

**Commissioner Bayard** drew attention to new carpeting that had been installed in the Court Room as the prior carpeting had been damaged by flooding from frozen water lines. Insurance had covered the cost of replacement. He stated new bulkheading had recently been installed, and a storm drain located on 31<sup>st</sup> Street had been replaced by Public Works employees who had done an excellent job. The Public Works Department was also in the process of labeling and assessing all storms drains in the Township. He announced the Brant Beach Homeowner's Association recently had Neighborhood Watch signs posted in the area. New greenhead fly traps had been constructed by the Boy Scouts and by the MATES program at Southern Regional High School. He added that he planned to contact Rutgers University for additional help with the greenhead fly traps.

Commissioner Palmer had no comments.

**Mayor Gove** announced the next meetings of the Board of Commissioners and the Land Use Board. She noted Long Beach Township was recognized with a Certificate of Achievement by the Ocean County Municipal Joint Insurance Fund for reducing the total number of job related injuries by 15% or more for the years 2004, 2005, and 2006. The Township was additionally recognized for earning 94 out of a possible 100 points in the 2007 Safety Incentive Program. She thanked the Long Beach Township Safety Coordinators for their efforts and the resulting recognition. She announced there would be a Special Public Meeting regarding beach safety on March 18<sup>th</sup> at 2:00 p.m., however there would be no public participation at the meeting.

### **OPEN PUBLIC SESSION**

**John Connelly / Beach Haven Crest** asked for a cost estimate for water quality and infrastructure improvement projects in the short and long term timeframe.

**Commissioner Palmer** advised that due to fluctuating costs, estimates were difficult to project. The current sewer project was a high priority and others projects would be examined in the near future.

**Dick Jeffries / Beach Haven Terrace** thanked the Mayor for the ceremony honoring local women. He asked the Commissioners to make local businesses aware of the fact that Ocean County would inspect recycling practices at their locations and issue fines to non-compliant owners.
