As you are aware, I represent Dolores Santoro, (the "Applicant") relative to a preliminary and final major site plan and bulk variance application that was filed on April 10, 2024. The application was carried from the May 8, 2024 Board meeting to allow the Applicant to submit revised plans. Enclosed please find the following:

At the May meeting, there were concerns from some of the owners of surrounding properties about the volume of cars backing out onto Sea Glass Lane. While the change of use does not impact the parking requirement, the proposed accounting
