## The Long Beach Township 2024 Best Practices Checklist

Governor Murphy issued the 2024 Best Practices Checklist to all New Jersey municipalities. It is a questionnaire that sets standards for local governments to assess municipal financial operations. The 2024 checklist included 69 questions pertaining to Financial Management, the Annual Budget, Capital Projects, Cyber Security, Environment, Ethics, Lead Remediation, Personnel, Procurement, Special Imp. Districts, Transparency, Utilities, Affordable Housing, Redevelopment and Public Safety. Responses were due by October 25<sup>th</sup>. Municipal governments must respond to each question and need to meet an established percentage of the checklist items in order to receive their final State Aid payment. The Board of Commissioners has reviewed the 2024 Best Practices Checklist submitted by the Chief Financial Officer. Based upon Long Beach Township's completed questionnaire, the Township shall receive its total final State Aid payment.
